

## RACKET & STRINGS

Manufacturer's IDs

## WRISTBAND

1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>** on each wristband

## SHORTS, TRACKSUIT BOTTOMS

2 manufacturer's IDs of **2 in<sup>2</sup>/13 cm<sup>2</sup>** placed on front or back

OR

2 manufacturer's IDs of **4 in<sup>2</sup>/26 cm<sup>2</sup>** placed as one on the front and one on the back

**Compression shorts**  
(In addition to the IDs on the shorts)

2 manufacturer's IDs of **2 in<sup>2</sup>/13 cm<sup>2</sup>**

OR

1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>**

## SHOES

Manufacturer's IDs on each shoe

## HAT, HEADBAND

1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>**

+

1 commercial ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>** – must be located on the side and worn so that it is positioned on the side of the head

## SOCKS

Manufacturer's IDs on each sock

## BAGS, TOWELS, OTHER EQUIPMENT, PARAPHERNALIA

Manufacturer's IDs

+

2 commercial IDs of **6 in<sup>2</sup>/39 cm<sup>2</sup>** on **one** bag

### SHIRTS, SWEATER, JACKET

#### Sleeves

2 positions individually measuring **6 in<sup>2</sup>/39 cm<sup>2</sup>** for commercial **AND/OR** manufacturer's IDs on each sleeve.

\*max. of 2 IDs within each **6 in<sup>2</sup>/39 cm<sup>2</sup>** position

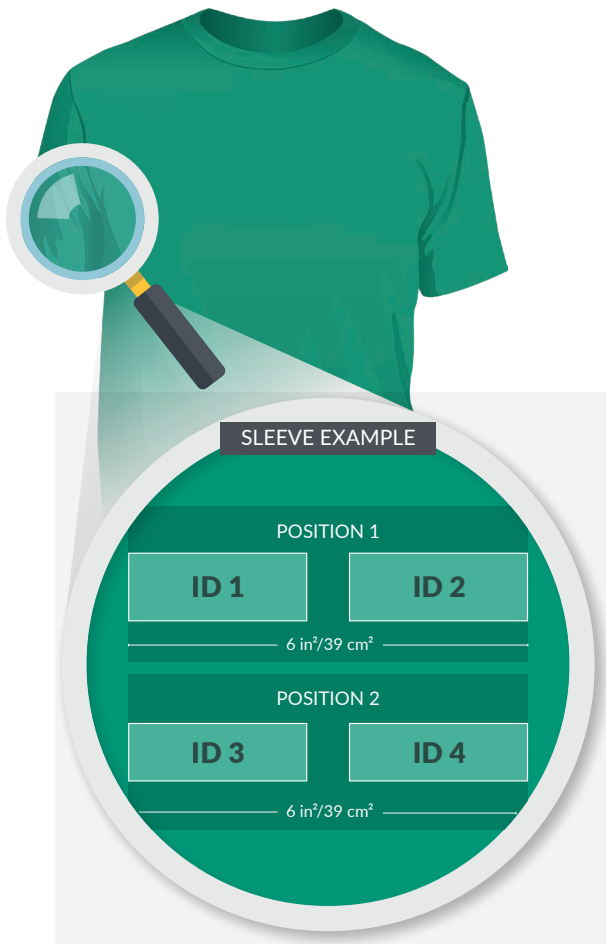
#### Compression sleeves

(In addition to the IDs on the sleeves)

2 manufacturer's IDs of **2 in<sup>2</sup>/13 cm<sup>2</sup>**

**OR**

1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>**



#### Sleeveless

2 positions of **6 in<sup>2</sup>/39 cm<sup>2</sup>** for commercial **OR** manufacturer's IDs on the front or collar of the shirt.

If no more than 1 ID is placed on the front or collar of the shirt



Then 1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>** may be placed on the back of the shirt.

#### Front, Back and Collar

2 positions of **6 in<sup>2</sup>/39 cm<sup>2</sup>** for commercial **OR** manufacturer's IDs on the front or collar.

If no more than 1 ID is placed on the front or collar of the shirt



Then 1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>** may be placed on the back of the shirt.

#### Other

Manufacturer's ID without any writing may be placed once or repeatedly within an area not to exceed **12 in<sup>2</sup>/77.5 cm<sup>2</sup>** in one of these locations:

- each of the shirt sleeves (if manufacturer ID is not on the sleeves)
- outer seams (sides of torso) of the shirt

A **Position** is an area on players' clothing within which identification(s) may be placed.

An **Identification (ID)** is a logo of the brand which may contain writing unless stated otherwise. Identifications may be either manufacturer or commercial (non-manufacturer).

On the sleeves only – maximum of two identifications are allowed within one position.

A combination of a commercial and a manufacturer identification can be placed within one position, but only on the sleeves.

### HAT, HEADBAND

1 manufacturer's ID of **3 in<sup>2</sup>/19.5 cm<sup>2</sup>** on the front

+

1 commercial ID of **3 in<sup>2</sup>/19.5 cm<sup>2</sup>** on the side

+

1 WTA logo of **2 in<sup>2</sup>/13 cm<sup>2</sup>\***

### SHIRT, SWEATER, JACKET, DRESS\*

#### Sleeves

1 commercial ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>** on each sleeve

+

1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>** on each sleeve

+

1 WTA patch of **4 in<sup>2</sup>/26 cm<sup>2</sup> \***

#### Sleeveless

2 commercial IDs of **4 in<sup>2</sup>/26 cm<sup>2</sup>** on the front

+

1 WTA patch of **4 in<sup>2</sup>/26 cm<sup>2</sup> \***

#### Front, back, collar

2 manufacturer's IDs of **2 in<sup>2</sup>/13 cm<sup>2</sup>**

OR

1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>**

#### Other

ID of manufacturer without any writing may be placed once or repeatedly within an area not to exceed **12 in<sup>2</sup>/77.5 cm<sup>2</sup>** in one of these locations:

- each of the shirt sleeves (if manufacturer ID is not on the sleeves)
- outer seams (side of torso) of the shirt

### BAGS, OTHER EQUIPMENT, PARAPHERNALIA

Manufacturer's IDs **OR** WTA logo

+

2 commercial IDs of **4 in<sup>2</sup>/26 cm<sup>2</sup>** on **one** bag

### RACKET, STRINGS

Manufacturer's IDs

### WRISTBAND

1 manufacturer's ID of **3 in<sup>2</sup>/19.5 cm<sup>2</sup>**

+

1 WTA logo of **2 in<sup>2</sup>/13 cm<sup>2</sup> \***

### SKIRT, SHORTS, LEGGINGS OR MID-THIGH COMPRESSION SHORTS WORN WITHOUT SKIRT OR SHORTS

2 manufacturer's IDs of **2 in<sup>2</sup>/13 cm<sup>2</sup>**

OR

1 manufacturer's ID of **4 in<sup>2</sup>/26 cm<sup>2</sup>**

#### Leggings or mid-thigh compression shorts worn with a skirt or shorts

1 manufacturer's ID of **2 in<sup>2</sup>/13 cm<sup>2</sup>** in addition to the IDs on the shorts or skirt

### SOCKS

Manufacturer's IDs of **2 in<sup>2</sup>/13 cm<sup>2</sup>** on each sock

### SHOES

Manufacturer's IDs

### \*WTA PATCH

A Player can **wear a total of 1** WTA patch

An **Identification (ID)** is a logo of the brand which may contain writing unless stated otherwise. Identifications may be either manufacturer or commercial (non-manufacturer).
