

RACKET & STRINGS

Manufacturer's IDs

WRISTBAND

1 manufacturer's ID of **4 in²/26 cm²** on each wristband

SHORTS

2 manufacturer's IDs of **2 in²/13 cm²** placed on front or back

OR

2 manufacturer's IDs of **4 in²/26 cm²** placed as one on the front and one on the back

Compression shorts

(In addition to the IDs on the shorts)

2 manufacturer's IDs of **2 in²/13 cm²**

OR

1 manufacturer's ID of **4 in²/26 cm²**

HAT, HEADBAND

1 manufacturer's ID of **4 in²/26 cm**

+

1 commercial ID of **4 in²/26 cm** - must be located on the side and worn so that it is positioned on the side of the head

SOCKS, SHOES

Manufacturer's IDs

BAGS, TOWELS, OTHER EQUIPMENT, PARAPHERNALIA

Manufacturer's IDs

+

2 commercial IDs of **6 in²/39 cm²** on **one** bag

Sleeves

2 positions individually measuring **6 in²/39 cm²** for commercial **AND/OR** manufacturer's IDs on each sleeve.

*max. of 2 IDs within each **6 in²/39 cm²** position

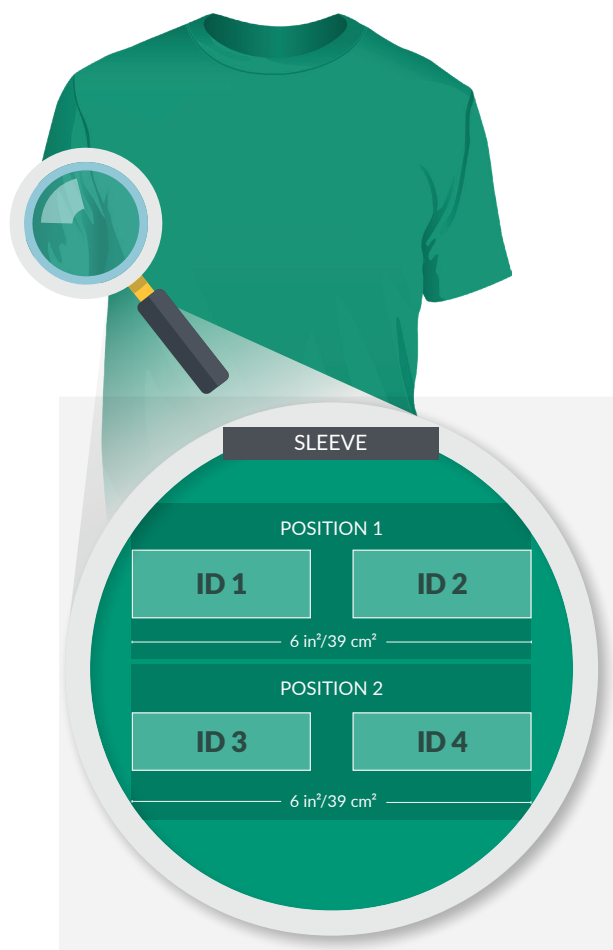
Compression sleeves

(In addition to the IDs on the sleeves)

2 manufacturer's IDs of **2 in²/13 cm²**

OR

1 manufacturer's ID of **4 in²/26 cm²**



SHIRTS, SWEATER, JACKET

Front, back and collar

2 manufacturer's or commercial IDs of **6 in²/39 cm²** on front or collar

OR

1 manufacturer's or commercial ID of **6 in²/39 cm²** on front or collar **AND**
1 manufacturer's ID of **4 in²/26 cm²** on the back

Other

Manufacturer's ID without any writing may be placed once or repeatedly within an area not to exceed **12 in²/77.5 cm²** in one of the locations:

- each of the shirt sleeves
(if manufacturer ID is not on the sleeves)
- outer seams (sides of torso) of the shirt

A **Position** is an area on players clothing within which identification(s) may be placed

An **Identification (ID)** is a logo of the brand which may contain writing unless stated otherwise. Identifications may be either manufacturer or commercial (non-manufacturer).

On the sleeves - maximum of two identifications are allowed within one position; a combination of a commercial and a manufacturer identification can be placed within one position.

HAT, HEADBAND

1 manufacturer's ID
of **4 in²/26 cm²**

+

1 commercial ID of
of **4 in²/26 cm²** over
the ear on the side

SKIRT, SHORTS, MID-THIGH LEGGINGS OR COMPRESSION SHORTS WORN WITHOUT SKIRT OR SHORTS

2 manufacturer's IDs of **2 in²/13 cm²**
on the front or back

OR

1 manufacturer's ID of **4 in²/26 cm²**
on the front and 1 manufacturer's ID
of **4 in²/26 cm²** on the back

**Sports bras, undergarments, mid-thigh leggings,
compression shorts worn under a skirt or shorts**
(In addition to the IDs on the top/skirt/shorts)

2 manufacturer's ID of **2 in²/13 cm²**

OR

1 manufacturer's ID of **4 in²/26 cm²**

RACKET, STRINGS

Manufacturer's IDs

WRISTBAND

1 manufacturer's ID
of **4 in²/26 cm²**

DRESS

Combination of a skirt and a shirt
(dividing dress at waist).

SOCKS, SHOES

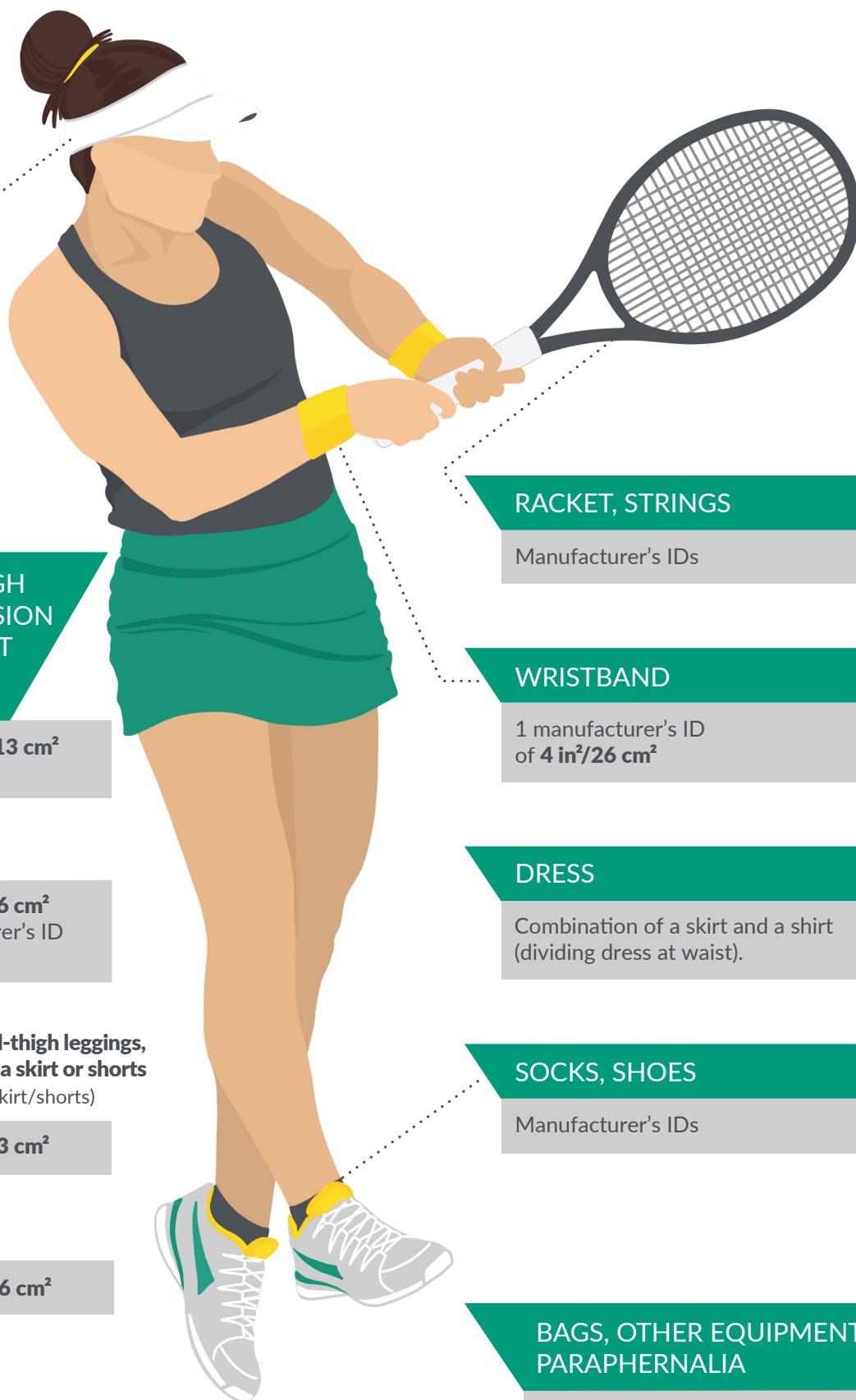
Manufacturer's IDs

BAGS, OTHER EQUIPMENT, PARAPHERNALIA

2 commercial IDs of
6 in²/39 cm² on one bag



Sleeves

2 positions individually measuring **6 in²/39 cm²** for commercial **AND/OR** manufacturer's IDs on each sleeve.

*max. of 2 IDs within each **6 in²/39 cm²** position

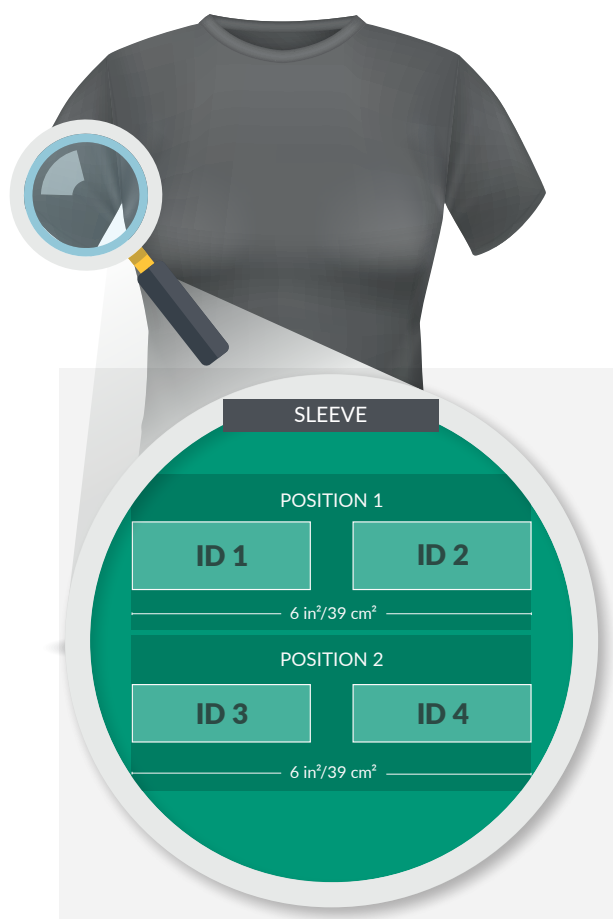
Compression sleeves

(In addition to the IDs on the sleeves)

2 manufacturer's IDs of **2 in²/13 cm²**

OR

1 manufacturer's ID of **4 in²/26 cm²**



SHIRTS, SWEATER, JACKET, DRESS

Front, back and collar

2 manufacturer's or commercial IDs of **6 in²/39 cm²** on front or collar

OR

1 manufacturer's or commercial ID of **6 in²/39 cm²** on front or collar AND
1 manufacturer's ID of **4 in²/26 cm²** on the back

Other

Manufacturer's ID without any writing may be placed once or repeatedly within an area not to exceed **12 in²/77.5 cm²** in one of the locations:

- each of the shirt sleeves (which replaces 1 of the positions for commercial or manufacturer IDs on each sleeve)
- outer seams (sides of torso) of the shirt

Without sleeves

4 manufacturer's or commercial IDs of **6 in²/39 cm²** on front or collar **only** if max 3 IDs are placed on the front and 2 of those are commercial

OR

3 manufacturer's or commercial IDs of **6 in²/39 cm²** on front or collar + 1 manufacturer's ID of **4 in²/26 cm²** on the back – if max 2 IDs on the front are commercial

A **Position** is an area on players clothing within which identification(s) may be placed.

An **Identification (ID)** is a logo of the brand which may contain writing unless stated otherwise. Identifications may be either manufacturer or commercial (non-manufacturer).
